- 1 RESIDENT TAX (Jūmin Zei)
- The amount of Resident Tax you have to pay depends on your previous year's (January December) income. Example: Your 2024 Resident Tax is calculated based on your 2023 income.
- 2 FIXED ASSET TAX (Kotei Shisan Zei)
- The Fixed Asset Tax applies to people who own fixed assets (house or land). It is levied on the 1st January each year.
- 3 LIGHT VEHICLE TAX (Kei Jidōsha Zei)
- The Light Vehicle Tax applies to people who own a light vehicle. It is levied on the 1st April each year.
- 4 NATIONAL HEALTH INSURANCE TAX (Kokumin Kenkō Hoken Zei)
- The amount of National Health Insurance Tax you have to pay depends on your income, number of dependents etc.
- \*For visa renewals, you will need a Proof of Tax Paid Certificate for your income tax (shotoku shōmei sho) and resident tax (kazei shōmei sho)
